The Board affirmed the decision of the Hearing Officer in the Matter of Charles Dellaria for violation of rules 4042.2(b) and 4012.11 and Justin Sallusto for violation of rules 4042.2(b) and 4012.11 but they reduced the suspensions as imposed by the stewards from 45 days to 30 days.
- 19. RECOMMENDATION TO FINE TRAINER DAVID BRANDWINE. The Board imposed a \$2,000. fine on trainer David Brandwine for his conduct in connection with entry of the horse Quick Skipper in the 6th race on December 6, 1981 at Roosevelt Raceway.
- 20. WESTERN REGIONAL OTB "VIB" BRANCH. The Board deferred the request by Western Regional Off-Track Betting Corporation to establish the VIB (Very Important Bettor) branch within the City of Buffalo. The request has been deferred until such time as the Board receives and reviews Western's plan of reorganization which was previously requested.
- 21. HEARING OFFICER REPORT IN THE MATTER OF WARREN CAMERON. The Board deferred the Hearing Officer's recommendation to confirm the suspension and disqualification of the licsense of Warren Cameron to participate in pari-mutuel harness racing pending its review of the record. The horse, Brand New Fella, trained by Warren Cameron was found to have raced with a drug, ethyl amino benzoate ("Benzocaine") in its system.
