MINUTES OF BOARD MEETING HELD ON MAY 18, 1984

A. MINUTES:

- 1. The Board approved the minutes of Board meeting held on April 30, 1984.
- 2. The Board approved the minutes of a Special Board meeting held on May 3, 1984.

B. FOR ENTRY INTO THE MINUTES:

- 1. MONTICELLO RACEWAY ROOSEVELT/CATSKILL OTB. For entry into the minutes, the Board's prior approval of April 24, 1984 of request by Monticello Raceway to discontinue Roosevelt Raceway's live calls into fourteen branches of Catskill Region Off-Track Petting Corporation.
- 2. NYRA COUPON PROMOTION. For entry into the minutes, the Board's prior approval of April 24, 1984 of request by New York Racing Association to place a coupon in the New York Post whereby the coupon shall entitle patrons to a \$1.00 reduction on Clubhouse and Grandstand admissions on May 5, 1984. The coupon will appear in the Post on May 4, 1984.

Buda pursuant to New York State Racing, Pari-Mutuel Wagering and Breeding Law, Section 309 and 321, 9NYCRR Section 4119.7 and 4119.8, and Subdivision 3 of Section 401 of the State Administrative Procedure Act.
- 10. FINGER LAKES RETROACTIVE PROMOTION. For entry into the minutes, the Board's prior approval of May 2, 1984 of request by Finger Lakes Racing Association for a retroactive approval, as a result of an error, to have free Grandstand admission on April 13, 20 and 27, 1984.
- 11. FINGER LAKES HANDICAPPING CONTEST. For entry into the minutes, the Board's prior approval of May 2, 1984 of request by Finger Lakes Racing Association to hold a handicapping contest for its fans on May 5, 1984.
- MONTICELLO RACEWAY ADMISSIONS. For entry into the minutes, the Board's prior approval of May 2, 1984 of request by Monticello Raceway to institute a \$1.00 admission charge including tax for its 1984 race meeting commencing on April 26, 1984.

For entry into the minutes, the Board's prior approval of May 7, 1984 of request by Monticello Raceway that in addition to the wagering pools already authorized, they want to include a quinella every race, an exacta every race and a daily double in the 5th and 6th races.
 - 15. YONKERS RACEWAY LICENSE AMENDMENT. For entry into the minutes, the Board's prior approval of May 7, 1984 of request by Yonkers Raceway to offer additional exacta and quinella wagers as follows: add quinella wagering to the 1st, 3rd, 4th, 5th, 6th, 7th, 8th, 9th and 10th races; add exacta wagering to the 1st and 2nd races.

- 6. FINGER LAKES TOKENS. The Board approved the request by Finger Lakes Racing Association to distribute 10,000 tokens which entitles the bearer to one free admission to the Grandstand.
