- 9. HEARING OFFICER REPORT IN THE MATTER OF OLE N. BACH: The Board imposed a six-month suspension, beginning June 19, 1987, due to a post race finding of the Drug Clenbuterol in the horse "Scotch Crown" which raced in the 4th race at Monticello Raceway on July 16, 1987 and finished first. Mr. Bach is the trainer for Scotch Crown.
- 10. SARATOGA RACEWAY PROMOTION: The Board approved a request from Saratoga Raceway to distribute 25,000 general admission, tax exempt admissions to be used in a promotion with "North Country" area hotels and motels and valid for November 21, 1987.
- 11. SARATOGA RACEWAY PROMOTION: The Board approved a request by Saratoga Raceway to print and distribute 10,000 general admission, tax exempt admissions for Saturday, August 8, 1987, to be used in a promotion with Radio Station WSCB.
