# MINUTES OF THE BOARD MEETING HELD ON SEPTEMBER 30, 1987

### A. MINUTES:

The Board approved the minutes of its meeting held on August 31, 1987.

  For entry into the minutes, the Board's prior approval of September 9, of a request by Western Regional Off-Track Betting Corporation to amend its Plan of Operation in order to receive live calls from Batavia Downs at eighteen (18) designated branches during the period September 9, 1987 thru December 6, 1987.

  For entry into the minutes, the Board's prior approval of September 11, of a request by Roosevelt Raceway to have a "Breeder's Crown" race on September 19, to be scheduled for the last race which is a triple. In the event that there
  - are more than eleven starters the race will have to be split, and it may be necessary to have a two-horse field.

    A Belmont Stakes rule waiver, if the number of horses warrants it, is therefore requested.
- 20. SUFFOLK REGIONAL-1987-1988 SIMULCAST FACILITY LICENSES:
  For entry into the minutes, the Board's prior approval of September 14, of an application by Suffolk Regional Off-Track Betting Corporation for nine (9) 1987-88 branch Simulcast facility licenses and one (1) Simulcast Theater License Plan of Operation for 1987-88.

  For entry into the minutes, the Board's prior approval of September 16, of an agreement between Roosevelt Raceway and Arlington Park with ITW at Maywood Park, the Meadows, and Northfield Park for the simulcast and acceptance of wagers on Breeders' Crown Aged Pace to be run on Roosevelt Raceway on September 18, 1987.
- 23. ROOSEVELT RACEWAY/GARDEN STATE PARK:

  For entry into the minutes, the Board's prior approval of September 18, of an agreement between Roosevelt Raceway and Garden State Park for the simulcast and acceptance of pari-mutuel wagers on the Breeders' Crown Aged Pace to be run at Roosevelt Racing on September 18, 1987.
- 24. ROOSEVELT RACEWAY/FREESTATE/PEORIA:

  For entry into the minutes, the Board's prior approval of September 18, of an agreement between Roosevelt Raceway, Freestate Racing Association, and Peoria Partners for the simulcast and acceptance of pari-mutuel wagers on the Breeders' Crown Aged Pace to be run on September 18, 1987, at Roosevelt Raceway.
- 25. GENESEE VALLEY HUNT/OFFICIALS:
  For entry into the minutes, the Board's prior approval of September 15, of an application by Genesee Valley Hunt, to be run on October 10.
- FLRA-RESCHEDULING OR APPROVED RACES:
  For entry into the minutes, the Board's prior approval of
  September 15, of a request by Finger Lakes Racing Association
  to reschedule two races from September 13 to September 15
  because of inclement weather and deteriorating track conditions
  on the 13th; and for permission to have a 1:00 p.m. post time
  rather than 1:30.

- 27. NYRA/BELMONT PROMOTION:
  - For entry into the minutes, the Board's prior approval of September 17, of a request by New York Racing Association, Inc. for approval of reduced admission charge i.e. free Grandstand or \$2.00 off Clubhouse on September 27, in a promotion in conjunction with Belmont.

  For entry into the minutes, the Board's prior approval of September 18, of a request by Finger Lakes Racing Association to continue scheduling 12 race cards on Tuesdays for the remainder of the 1987 racing season.
- 33. NYRA/WAIVER OF RULE 4011.20(f):

  For entry into the minutes, the Board's prior approval of September 18, of a request by New York Racing Association, Inc. to waiver rule 4011.20(f) in order to offer an exacta pool for Marlboro Cup in the event that said race has less than six (6) starters. If less than five (5) starters, no exacta wagering will be conducted.
- 34. CDROTBC/DELMAR FACILITY:
  For entry into the minutes, the Board's prior approval of September 18, of a request by Capital District Regional OTBC to amend its Simulcast Plan of Operation and offer food and non-alcoholic beverages at its Delmar simulcast facility.
- 35. MONTICELLO RACEWAY-ADDITIONAL RACE DAY:
  For entry into the minutes, the Board's prior approval of
  September 24, of a request by Monticello Raceway to add
  Monday, September 28 to its race schedule, post time being
  7:35 p.m.

- 36. NYCOTBC-SUPER DERBY VIII:
  For entry into the minutes, the Board's prior approval of September 23, of a request by New York City Off-Track Betting Corporation, on behalf of all New York State regional off-track betting corporations, to accept wagers on the Super Derby VIII to be run on Sunday, September 27, 1987.
- 37. NYRA-OUT OF STATE SIMULCAST:
  For entry into the minutes, the Board's prior approval of September 18, of an executed agreement between NYRA and Fairmount Park, and Pocono Downs for the simulcast and acceptance of pari-mutuel wagers on the 1987 Marlboro Cup.
- 38. CDROTBC/ROOSEVELT RACEWAY:
  For entry into the minutes, the Board's prior approval of September 17, of a request by Capital District Regional Off-Track Betting Corporation to accept wagers on the Aged Horse and Gelding Pace to be run on September 18, at Roosevelt Raceway as part of the Breeders' Crown Series.
- FLRA/POST TIME CHANGE:

  For entry into the minutes, the Board's prior approval of September 22, of a request by Finger Lakes Association for permission to change its post time to 1:05 p.m., effective September 29, 1987, until the end of Daylight Savings Time on October 25, 1987. Subsequently post time will be 12:45 on week days and 1:05 on Sundays.

## FOR BOARD APPROVAL

- 1. JOCKEY DENNIS CARR-APPRENTICE ALLOWANCE: The Board approved the request on behalf of Apprentice Jockey Dennis Carr for a 94 day extension of his apprentice allowance due to track injury.
- 2. MONTICELLO RACEWAY/CAPITAL EXPENDITURE: The Board approved the request by Monticello Raceway for a Capital expenditure of \$250,000 to provide Drug Testing facilities and indoor paddocks.
- 3. <u>JERRY BELMONTE-APPRENTICE ALLOWANCE:</u> The Board approved the request on behalf of apprentice jockey, Jerry Belmonte for an extension of his apprentice allowance for five (5) days due to injury sustained during a riding accident on August 7, 1987.
- 4. PROPOSED RULE CHANGES 4011.15(m), 4011.20(f), 4122.39(h), 4122.42(1), 4217.10(1), 4217.13: The Board issued a proposal to amend the above-captioned rule to allow quinella and exacta (but not trifecta) pools to continue with less than six starters, provided that at least six separate betting interest show in the paddock and according to stipulations attached hereto.

- 5. HEARING OFFICER REPORT-ROBERT K. WARNER:

  Mr. Warner has appealed the denial of his 1987 owner-trainerdriver license on the ground that he lacks the required character and fitness to participate in harness racing as a result of his role in a fixed race on January 5, 1982. The Board reconfirmed the denial.
- 6. PROPOSED ADOPTION RULE 4109.1, 4109.3(k):
  The following rule was adopted by the Board:

- a). Repeal of the requirement that an owner claim a horse with a 20% penalty. Harness Rule 4109.3(k).
- b). Section 4109.1 of Harness Rules to allow open claiming with 72 hours notice.
- 7. BATAVIA DOWNS-CAPITAL IMPROVEMENT FUND: A request was made for Batavia Downs for a capital expenditure of \$45,299.49. A total amount of \$7,507.19 has been disallowed. The Board therefore, approved the amount of \$37,792.30.
- 8. BATAVIA DOWNS-CAPITAL IMPROVEMENT FUND: The Board approved a request by Batavia Downs for Capital expenditure of \$75,862 for video equipment purchase.
- 9. WROTBC/BATAVIA DOWNS LIVE CALLS: The Board approved the request by Western Regional Off-Track Betting Corporation to amend its Plan of Operation, to cease live calls from Batavia Downs at Redwing Plaza and commence receiving live calls at Goodman Plaza, effective immediately.
- 10. CATSKILL REGIONAL OTBC MONTICELLO RACEWAY: The Board approved a request by Catskill Regional Off-Track Betting Corporation to amend its Simulcast Plan of Operation to authorize unlimited simulcasting of Monticello Raceway racing events into selected Branches through January 1988, and simulcasting of Roosevelt and Yonkers racing events to all Catskill OTB branches.
- 11. RECONSIDERATION BOARD DECISION CAPITAL OTB'S REQUEST TO ACCEPT WAGERS ON THOROUGHBRED RACES FROM MEADOWLANDS ON NYRA DARK DAYS: Request by Capital District Regional Off-Track Betting Corporation for reconsideration of its negative ruling on their application to accept wagers on Meadowlands thoroughbred races on NYRA Dark Days.

In addition, Roger L. Dworsky, Assistant Secretary and Deputy Counsel, Capital District Regional Off-Track Betting Corporation, by telephone this date, asked that the Board deem Mr. Etkin's letter a request for reconsideration by the Board, for the reasons set forth therein.

12. NYCOTBC/HOWARD GIORDANO:

The Board approved the appointment of Howard P. Giordano as Executive Officer, with the title of President of the New York City Off-Track Betting Corporation. Approval of his appointment as member of the Board of Directors of the New York City Off-Track Betting Corporation was deferred, pending the receipt of an opinion of the Attorney General, relating to the compatability of said offices.
