- 1. Approved minutes of the Board Meeting held on July 31, 1990.
- (B) FOR ENTRY INTO THE MINUTES
- 1. VERNON DOWNS/COUPON OF SYRACUSE MILE PROGRAM
 For entry into the minutes, the Chairman's prior approval
 of a request by Vernon Downs to promote racing at Vernon
 Downs by offering a coupon that will appear on the back page
 of the Syracuse Mile program.
- 2. NYRA/AGREEMENT WITH RADIO STATION WGY
 For entry into the minutes, the Chairman's prior approval
 of a request by the New York Racing Association to provide
 the call of its featured races, on a delayed basis at
 Saratoga Racetrack to radio Station WGY.
- 3. VERNON DOWNS/ADDITIONAL TRIFECTA FOR THE THOMAS P. GAINES
 For entry into the minutes, the Chairman's prior approval
 of a request by Vernon Downs to add an additional trifecta
 on the 10th race of the Thomas P. Gaines Memorial to be
 held on Saturday, July 28, 1990.
 Also, for entry into the minutes, the Chairman's prior
 approval to offer exacta wagering with five (5) betting
 interests and trifecta wagering with (6) betting interests
 in the elimination races 4, 5, and 6.
- 4. CDROTBC/TO AMEND PLAN OF OPERATION
 For entry into the minutes, the Chairman's prior approval of a request by Capital District Regional Off-Track Betting Corporation to amend its simulcast plan of operation for a special demonstration simulcast theater at the Friar Tuck Inn, Catskill, New York for the period of July 30, 1990 through June 30, 1991.
- 5. APPLICATIONS OF ROTBC'S/TO ACCEPT WAGERS
 For entry into the minutes the Chairman's prior approval
 of a request by New York City, Catskill, Nassau, Suffolk and
 Western Regional Off-Track Betting corporations to accept
 wagers on the 1990 Haskell Invitational on Saturday, July 28,
 1990. Also, previously approved by the Chairman a request
 by Capital District Regional Off-Track Betting Corporation
 to accept wagers on the 1990 Syracuse Mile and 1990 Haskell

Invitational and a request by the New York Racing Association, Saratoga Raceway and Yonkers Raceway to accept wagers on the 1990 Haskell Invitational on Saturday, July 28, 1990.

6. BATAVIA DOWNS/LICENSE AMENDMENT

For entry into the minutes, the Chairman's prior approval of a request by Batavia Downs to make changes in their Summer/Fall Schedule as outlined in their letter of June 18, 1990 with the exception of Labor Day (when Finger Lakes Racing Association will be operating) at which time their first post time will be at 4:30p.m.

7. NYRA/PARI-MUTUEL WAGERING FEATURES FOR THE 1990 SARATOGA RACE MEET

For entry into the minutes the chairman's prior approval of a request by the New York Racing Association of the pari-mutuel features for the Saratoga meet as outlined in their letter of July 11, 1990.

8. APPLICATION OF WROTBC/TO AMEND PLAN OF OPERATION
For entry into the minutes, the Chairman's prior approval of an application of Western Regional Off-Track Betting Corporation to amend its simulcast plan of operation to simulcast races from Batavia Downs into 22 branches for the entire Summer/Fall meet and to simulcast into 4 branches while Vernon Downs is dark (during the period of August 1, 1990 through December 1, 1990) as outlined in their letter of July 27, 1990.

9. NYRA/AUGUST SIMULCAST SCHEDULE

For entry into the minutes, the Chairman's prior approval of a request by the New York Racing Association of a list of tracks with which NYRA has executed agreements for the simulcast and acceptance of pari-mutuel wagers in the month of August as outlined in their letters of July 24 and 27,1990.

10. BOARD DIRECTIVE

The Chairman's prior approval of the Board Directive to Finger Lakes and all Harness tracks (except Yonkers and Buffalo Raceways) directing all applicable tracks to open trust accounts under the control of a trustee who is to be approved.

11. MONTICELLO RACEWAY/REQUEST TO CHANGE FORMAT

For entry into the minutes, the Chairman's prior approval of a request by Monticello Raceway to modify their racing format to include 13 races on weekends as outlined in their letter of July 6, 1990.

12. NYRA/ADDENDUM TO AUGUST SIMULCAST SCHEDULE

For entry into the minutes, the Chairman's prior approval of a request by the New York Racing Association to add the various tracks to the August Simulcast Schedule as outlined in their letter of July 27, 1990.

13. CDROTBC/TO ACCEPT WAGERS

For entry into the minutes, the Chairman's prior approval of a request by Capital District Regional Off-Track Betting Corporation to accept wagers and the simulcast signal of the 1990 Hambletonian to be run at the Meadowlands, August 4, 1990 pursuant to Section 906 of the Racing Pari-Mutuel Wagering and Breeding Law as amended.

14. CDROTBC/TO ACCEPT WAGERS

For entry into the minutes, the Chairman's prior approval of a request by Capital District Regional Off-Track Betting Corporation to accept wagers and the "live call" of races run at Syracuse Mile during the 1990 Syracuse Mile (August 4, 5, 11, 12, 17, 18 and 19, 1990.

15. YONKERS RACEWAY/FREE ADMISSION PASSES

For entry into the minutes, the Chairman's prior approval of a request by Yonkers Raceway to distribute free clubhouse passes for the evening of the International Trot, on Sunday, August 5, 1990.

16. NYRA/SIMULCAST TO OCALA BREEDERS SALES

For entry into the minutes, the Chairman's prior approval of a request by the New York Racing Association to simulcast to the Ocala Breeders Sales on August 23-31st and October 5-13, 1990.

17. WROTBC/TO CONDUCT PICK-3 WAGERING

For entry into the minutes, the Chairman's prior approval of a request by Western Regional Off-Track Betting Corporation to offer a Pick-3 wager on Batavia Downs' races 4, 5, & 6 during their Summer/Fall meet and consent thereto by Batavia Downs.

18. CDROTBC/PROMOTION

For entry into the minutes, the Chairman's prior approval of a request by Capital District Regional Off-Track Betting Corporation to offer two people to enter CDROTBC's Cash Give-Away Booth. The two people would be chosen after every NYRA race on August 30, 1990.

 For entry into the minutes, the Chairman's prior approval of a request by Syracuse Mile to bar T.K's Skipper from wagering on Sunday, August 12, 1990 at the Syracuse Mile.
- 24. NYRA/ADDENDUM TO AUGUST SIMULCAST SCHEDULE
 For entry into the minutes, the Chairman's prior approval of a request by the New York Racing Association of a list of tracks with which NYRA has executed agreements for the simulcast and acceptance of pari-mutuel wagers on The Travers as outlined in their letter of August 15, 1990.
- 25. YONKERS RACEWAY/LICENSE AMENDMENT AND PROMOTIONAL REQUEST For entry into the minutes, the Chairman's prior approval of a request by Yonkers Raceway to add Sunday, September 2, 1990 to its racing Schedule and offer free grandstand admission and free general parking for the month of September.

26. SARATOGA RACEWAY/WAGERING FORMAT REQUESTS

For entry into the minutes, the Chairman's prior approval of a request by Saratoga Raceway to conduct exacta wagering with an additional daily double (Races 10-11) for the feature race on Friday, August 17, 1990.

 For entry into the minutes, the Chairman's prior approval of a request by Vernon Downs to conduct a CPI Photo Finish Promotion via commercials on radio stations WFBL and WKFM as outlined in their letter of August 17, 1990.

For entry into the minutes, the Chairman's prior approval of a request by Yonkers Raceway to simulcast the Cane Pace Final on Saturday, August 25, 1990 to Pocono Downs.

 jockey license.

 The Board approved the readoption of the Win-3 and Trifecta rules which were previously adopted on May 31, 1990 on a emergency basis.

11. NYRA/BELMONT PARK TO AQUEDUCT SIMULCASTING

The Board approved its amended simulcast plan of operation of their license to conduct the simulcast of races from Belmont Racetrack to Aqueduct Racetrack for August 1990, under the same conditions regarding job security as delineated in Section 1010 of the Racing Law.

D. BOARD DETERMINATION

- 1. YONKERS RACEWAY/SIMULCAST OF THE WILLIAM HAUGHTON MEMORIAL
 The Board approved the request by Yonkers Raceway to
 simulcast the William Haughton Memorial Series to be held on
 Saturday, November 17, 24, and the final on Saturday,
 December 1, 1990 to Garden State Park.
- 2. BATAVIA DOWNS/SIMULCAST OF THE NORTH AMERICAN SERIES FINAL
 The Board approved the request by Batavia Downs to simulcast
 the North American Series Final to Freehold Raceway on
 September 1, 1990.
- 3. <u>HEARING OFFICER REPORT IN THE MATTER OF FRANCISCO MEDERO</u>
 The Board approved the Hearing Officers' recommendation that Mr. Francisco Medero's ten (10) day suspension be confirmed.
- 4. WIN 3 AND TRIFECTA/RULE ADOPTION

 The Board approved the adoption to amend the Thoroughbred racing rules (Section 4011.24) authorizing a new betting pool and prescribing the rules under which the pool is to be conducted.

 Also, approved the Board the adoption to amend the Thoroughbred racing rules (Section 4011.22) relating to the rules under which trifecta betting is conducted with coupled entries.
- 5. RULE ADOPTION/ADMINISTRATIVE HEARING RULES-PART 5402
 The Board approved the adoption of certain rules relating to the procedures for conducting adjudicatory hearings as set forth in the Governor's Executive Order No. 131.
- 6. VERNON DOWNS/GIVEAWAY ON THE FINAL 10 WEEKENDS OF THE 1990
 RACING SEASON
 The Board approved the request by Vernon Downs to hold a giveaway on the final ten (10) weekends of the 1990 racing season, September 7th through November 10, 1990 as outlined in their letter of August 15, 1990.
- 7. GENESEE VALLEY HUNT, INC./HUNT MEETING LICENSE
 The Board approved the application by Genesee Valley Hunt to conduct a hunt meeting on October 13, 1990.

- 8. <u>GUIDELINES FOR 1990-91 SIMULCAST FACILITY LICENSING</u>
 The Board approved the proposed adoption of guidelines governing 1990-91 Simulcast Facility Licensing Process. Guidelines have been revised to:
 - (a) insure compliance with all applicable provisions of law; and
 - (b) include all modifications required by Chapter 346 of the Laws of 1990.
- 9. APPLICATION OF NYC, NASSAU & SUFFOLK ROTBC'S /TO ACCEPT WAGERS The Board approved the applications of New York City, Nassau and Suffolk Regional Off-Track Betting to accept wagers and display the simulcast of Finger Lakes races on Wednesdays, Fridays, and Saturdays during August, 1990.
- 10. FINGER LAKES/CAPITAL IMPROVEMENT FUND WITHDRAWAL
 The Board approved the request by Finger Lakes to withdraw \$35,130.53 from the Capital Improvement Fund.
- 11. NYRA/CATEGORY OF RACING OFFICIALS
 The Board approved the request by the New York Racing
 Association that Mr. Marshall Cassidy be in Category I as a
 Utility Official and as an Alternate Steward representing
 NYRA in Category III.
