The gaming facility will feature a high limit gaming area with an estimated 25 table games and 150 slots in a separate room from the main casino. The high limit will feature a small seating area and bar located adjacent to the VIP Lounge. Both areas will have access to a dedicated outdoor patio.

The Gaming Facility also will have a poker room with a separate entrance from within the main



casino. There will be an estimated 30 poker tables, and the room will include a dedicated reception area, cage and small seating area.

6. Layout of cage area, including number of windows, and a breakdown of special-use windows, if any.

In order to offer convenience to our guests and to adequately facilitate service for the number of table games players anticipated, the property will have two cages. The main cage accommodates 8 teller windows and 5 automatic teller machines, as well as a discreet employee transaction window. A second "satellite cage" located on the opposite side of the gaming floor has 4 teller windows plus 4 automated stations.

For the Cage team members, there are two independent areas to facilitate their transactions. One is located off the casino floor, where a Team Member will be able to bring change from the casino floor into the Employee Bank. From there, money can be transferred across a counter to the Cage attendant who logs the transaction and then turns it over to the Main Bank attendant where it is again counted and transferred to the lower level via a designated / secure elevator directly to the count area. Once the transfer occurs into the Soft Count room, the second independent Team Member has access to that room through an electronic 'man trap' that cannot be accessed without security clearance.

7. Description of size, layout, and location of count room.

Money from the Soft Count room is logged and stored. Removal is only done by guards with special clearance. As an additional measure of security, the perimeter walls and ceilings will include tightly spaced expanded metal lathe. The room is approximately 1,200 square feet. The count area has a separate, designated secure corridor connecting directly to the Armored Car Bay. The combined floor area designated for both cages and the count area is approximately 5,100 square feet.

The Player's Club is centrally located in the casino and is highly visible and accessible for guests since it is located on the main casino floor. Guests will be greeted by a Team Member at one of the multiple stations at the club. The Team Member has access to a back room that will include an office and storage space for promotional events. The area is approximately 1,000 sq. ft.
