2. OWNERSHIP OF LAND

On April 2, 2014, PPE Casino Resorts NY, LLC (which owns a 50% interest in the Applicant), as Purchaser, entered into two Purchase and Sales Contracts, one contract with Infinity Holdings Northeast, LLC for Parcel 1 (the 84.40 acre parcel with an address of 4-14 Fairway Drive, Village of South Blooming Grove, New York) and one contract with Rieger Construction, Inc. for Parcel 2 (the adjacent 40 acre parcel). Both contracts were assigned and assumed by the Applicant as of April 25, 2014.

Parcel 1 is presently owned in fee simple by Infinity Holdings Northeast, LLC. Infinity Holdings Northeast, LLC acquired Parcel 1 on December 31, 2009 from David Plotkin. David Plotkin acquired the fee simple interest in Parcel 1 on March 1, 1991.

Parcel 1 contains three month to month tenants that will be terminated prior to the acquisition of Parcel 1 by the Applicant. Parcel 1 is encumbered by the following:

Parcel 2 is presently owned in fee simple by Rieger Construction Inc. Rieger Construction Inc. acquired Parcel 1 on January 30, 1974 from M. Jerome Rieger.

Parcel 2 is unoccupied unimproved land. Parcel 2 is encumbered by the following
