

## Exhibit VIII. C.1.a

The Resorts World Hudson Valley Project Site is located in the Town of Montgomery, Orange County, New York. As shown in Figures VIII. C.1.a-1 through 3 below, this location brings with it numerous advantages. Resorts World Hudson Valley is approximately 75 miles, or one and a half hour's drive, from New York City. This proximity ensures that the project will be easily accessible from the higher disposable income and population of that metropolitan area, as well as the approximately 50 million tourists visiting New York City annually. Resorts World Hudson Valley is also close to large population centers in New Jersey and Connecticut and therefore is well positioned to attract interstate patrons, resulting in net economic growth within New York State. 
#### Figure VIII. C.1.a-1. Regional Positioning of Project Site




Figure VIII. C.1.a-4. Project Site Tax Lots
