

In the event that Hampton Inn JC becomes overbooked and needs to make a reservation if available at Traditions at the Glen the same rate will be honored.



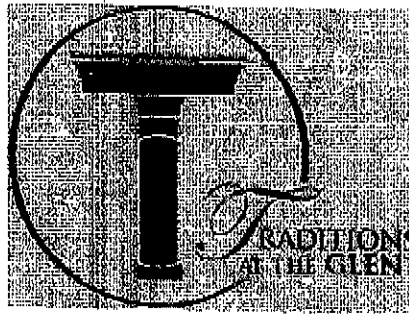

In the event that Hampton Inn & Suites becomes overbooked and needs to make a reservation if available at Traditions at the Glen the same rate will be honored.



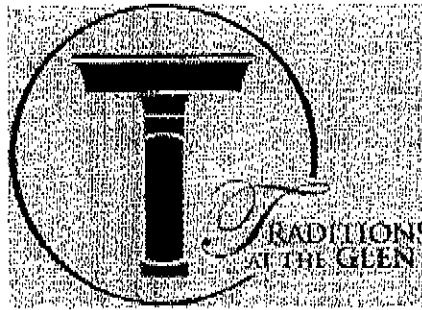



In the event that Quality Inn becomes overbooked and needs to make a reservation if available at Traditions at the Glen the same rate will be honored.



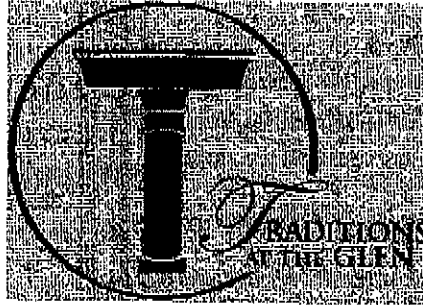





In the event that Holiday Inn Express becomes overbooked and needs to make a reservation if available at Traditions at the Glen the same rate will be honored.



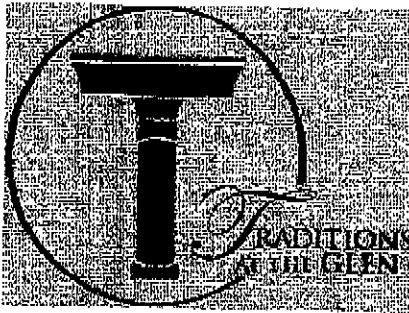
