Stewards Inquiry Race 2- Inquiry into the start, #1A Southbeachsandy (Rodolfo Ignacio) reared at the start. After reviewing the race video in the judgment of the Stewards #1A Southbeachsandy caused her own problems and the race is official as is.

Stewards Inquiry Race 4- Inquiry in the vicinity of the 1/4 pole, #2 Tale of a Song (Oscar Gomez) clipped heels with #1 Rye Z Rolls (Jaime Rodriguez). After reviewing the race video in the judgment of the Stewards the race is official as is.

Incident Race 4- #2 Tale of a Song trained by Linda Rice and ridden by Oscar Gomez clipped heels unseating the rider. Rider was uninjured and horse walked off the track under his own power.

Stewards Inquiry and Jockey Objection Race 4- Inquiry into the stretch run between #3 Rob the Weezer (Jose Baez) and #4 Colossus Michael Davila, Jr. After reviewing the race video in the judgment of the Stewards the race is official as is. Also fourth place finisher #5 Take a Bite (Alexis Valdes) claimed foul against first place finisher #1 Scott Hill (Oscar Gomez) for alleged interference in the stretch. The claim of foul was disallowed.

Stewards Inquiry and Jockey Objection Race 8- Jockeys of the third place finisher #1 Majestic Guy (John Davila, Jr.) and second place finisher #2 Threeskills (David Lopez) claimed foul against first place finisher #3 Papa Shot (Harry Hernandez) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this altered the finish of the race and #3 Papa Shot is disqualified from first and placed third. New order of finish 2, 1, 3, 4, 5.

Stewards Inquiry and Jockey Objection Race 3- Jockey of fourth place finisher #2 Happy Again (Jason Simpson) claimed foul against second place finisher #1 Fa Niente (Jose Baez) and third place finisher #6 Bo' Hopes (Gabriel Suarez) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this altered the outcome of the race and #6 Bo' Hopes is disqualified from third and placed fourth. New order of finish: 4, 1, 2, 6, 5, 3.

Stewards Inquiry Race 6- Inquiry in the vicinity of the 5/8 pole, #8 Jeb (Luis Perez) clipped heels with #7 Tropical Joy (Jacqueline Falk). After reviewing the race video in the judgment of the Stewards the race is official as is.

Incident Race 6- #8 Jeb trained by Dylan Clarke and ridden by Luis Perez unseated the rider at the 5/8 pole.

Jockey Movie Review Race 3- Stewards Stuart Rainey, Rick Coyne and Don Combs met with rider Gabriel Suarez to review the Stewards Inquiry from the race. After review jockey Gabriel Suarez was suspended seven racing days.
