Stewards Inquiry Race 9- Inquiry into the start, #12 Kirstins Patchouli (Harry Hernandez) ducks in sharply slamming #11 Moonshine Queen (Carlos Camilo) causing a chain reaction. After reviewing the race video in the judgment of the Stewards this incident altered the finish of the race and #12 Kirstins Patchouli is disqualified from eighth and placed tenth. New order of finish: 4, 6, 1, 9, 5, 7, 10, 11, 8, 12.

Stewards Inquiry and Jockey Objection Race 6- Jockey of the second place finisher #5 Field Sense (Rodolfo Ignacio) claimed foul against the first place finisher #7 Jacapo (Andy Hernandez Sanchez) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved the Stewards disqualified #7 Jacapo from first and placed him second. New Order of Finish: 5, 7, 9, 4, 10, 8, 3.

Stewards Inquiry Race 10- Inquiry into the stretch run, #10 Act Surprised broke down in the vicinity of the 1/8 pole. After reviewing the race video no action was taken by the Stewards.

Equine Death Race 10- #10 Act Surprised trained by Christopher Progno and ridden by Rodolfo Ignacio was pulled up in the stretch and the rider jumped off the horse. Horse found to have fractured left front shoulder and was euthanized on track.

No Claims Occurred

Ruling- Andy Hernandez- Jockey- #7 Jacapo, ridden by Jockey Andy Hernandez Sanchez, was disqualified from first position and placed second for interfering with #5 Field Sense in the stretch, during the running of the 9th race on November 16, 2017. Having waived his right to appeal, Jockey Andy Hernandez Sanchez is suspended for 3 racing days, effective Friday, November 24, 2017; Monday, November 27, 2017 and Tuesday, November 28, 2017, inclusive.
