After reviewing the race video and speaking to the riders involved the Stewards made the race official as is.

Stewards Inquiry and Jockey Objection Race 6- Jockey of the third place finisher #2 Tender Boy (Rodolfo Ignacio) claimed foul against the second place finisher #5 Stormy Highway (Andre Worrie) for alleged interference in the vicinity of the 1/4 pole. After reviewing the race video and speaking to the riders involved the Stewards made the race official as is.
