**Stewards Inquiry and Jockey Objection Race 1-** Jockey of the second place finisher #3 Austin's Xchanger (Jason Simpson) claimed foul against the first place finisher #1 Peanutbutter Shake (Alexis Valdes) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved the Stewards disqualified #1 Peanutbutter Shake from first and placed him second. There was a review of this race video the following day with the riders and the Stewards decided to suspend Rider Alexis Valdes for three racing days.

**Stewards Inquiry and Jockey Objection Race 5-** Jockey of the third place finisher #3 D'funnything (Harry Hernandez) claimed foul against the second place finisher #7 Readyheartandsoul (Joel Sone) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved the Stewards made the race official as is.

**Stewards Inquiry Race 8-** Inquiry into the start, #3 Maple Mo (Oscar Gomez) broke slow from the gate. After reviewing the race video the Stewards made the race official as is.

**Incident Race 1-** #2 Jomary's the Great trained by Eduardo Maver, Jr. and ridden by John Berrios stumbled at the start and unseated the rider. Horse and rider were uninjured.

**Rulings- Eduardo Maver, Jr.- Owner-Trainer-** Fined \$100 for failing to take care of business in a proper manner regarding Lasix, necessitating the scratch of "Sweet Birdie" on May 8, 2017.

**Alexis Valdes- Apprentice Jockey-** Apprentice Jockey Alexis Valdes, rider of "Peanutbutter Shake" (#1), is suspended for 3 racing days effective Monday, May 15, 2017; Tuesday, May 16, 2017; and Saturday, May 20, 2017, for interfering with "Austin's Xchanger" (#3) in the stretch, during the running on the first race on May 10, 2017.
