**Stewards Inquiry and Jockey Objection Race 5-** Jockey of the third place finisher #6 Mimi Media (Rodolfo Ignacio) claimed foul against the second place finisher #7 Eye's On You (Jeremias Flores) and first place finisher #5 Katina Got Even (Luis Perez) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards #7 Eye's On You was disqualified from second and placed third. New order of finish: 5, 6, 7, 8, 2, 1, 4. The Stewards held a review of the race with the riders involved and after reviewing the video suspended rider Jeremias Flores for careless riding.
