**Stewards Inquiry and Jockey Objection Race 6-** Jockey of fifth place finisher #2 Johnny G (Jose Baez) claimed foul against first place finisher #4 My Way or Dubaiway (Oscar Gomez) and second place finisher #7 Exact Again (Jose Gutierrez) for alleged interference in the stretch. After reviewing the video of the race in the judgment of the Stewards the actions of #7 Exact Again affected the outcome of the race and #7 Exact Again is disqualified from second and placed fifth. New Order of Finish: 4, 3, 1, 2, 7, 6, 8.

No Incidents or Claims Occurred

**Jockey Movie Review Race 6-** Stewards Stuart Rainey, Rick Coyne and Don Combs met with riders Jose Baez, Oscar Gomez and Jose Gutierrez to review the running of the race and the inquiry and objection from the race. After review the Stewards issued Mr. Gutierrez a suspension for three racing days.

After reviewing the race video in the judgment of the Stewards the race was made official as is.

**Jockey Movie Review Race 8-** Stewards Stuart Rainey, Rick Coyne and Don Combs met with riders Pedro Rodriguez, David Lopez and others in regard to the objection from race eight. After review no action was taken by the Stewards.

**Horses Claimed- Race 6-** #2 Manhattan Gin Claimed by Trainer Luis Gutierrez for Carlos V. Dominguez

**Ruling- Jose A. Gutierrez- Jockey-** #7 Exact Again was disqualified from 2nd position and placed 5th for interfering with #1 Royalty Reigns in the stretch during the running of the 6th race on Tuesday, June 21, 2016. Jockey Jose Gutierrez is suspended for three racing days effective Thursday, June 23, 2016; Saturday June 25, 2016 and Monday June 27, 2016.
