**Stewards Inquiry and Jockey Objection Race 9-** Jockey of the fourth place finisher #4 Point and Go (Jason Simpson) claimed foul against third place finisher #7 Piscesbymoonlight (Pedro Rodriguez) for alleged interference in the stretch. After reviewing the race video and speaking with the riders involved in the judgment of the Stewards this did not affect the outcome of the race and the race is official as is.

**Equine Death Race 7-** #6 Anchorwoman trained by Arcadio Lopez and ridden by Carlos Camilo was pulled up in the vicinity of the 1/4 pole and was euthanized on the track.
