No Inquiries, Incidents or Claims Occurred

Rulings- Arcadio Lopez- Owner-Trainer- Having received a report from the NYS Gaming Commission Equine Drug Testing Laboratory of the finding of orphenadrine (norlfex) in the body fluid sample taken from the horse #7 Jarrod's Commando which finished second in the 2nd race on June 4, 2016; and having waived his right to appeal Owner/Trainer Arcadio Lopez is suspended for 15 calendar days effective Thursday, July 7, 2016 through Thursday, July 21, 2016, inclusive, and fined \$500.

Furthermore, "Jarrod's Commando" is disqualified from any part of the purse and the stewards order the purse redistributed as follows: 1. #5 Danceteria 2. #1 Maybrys Challenge 3. #3 Can'tcatchjack 4. #4 John's Sharp Humor 5. #2 Stalagmite

Adrienne N. D'Alessandro- Owner-Trainer- Fined \$100 for failing to present horse Awesome Lute to the paddock for the 5th race on June 27, 2016, necessitating a late scratch.

Adrienne N. D'Alessandro- Owner-Trainer- Fined \$50 for failing to appear before the stewards after receiving a notice.

After reviewing the race video the Stewards made the race is official as is.

Equine Death Race 5- #7 Mary's Legacy trained by Jeffrey Englehart and ridden by Oscar Gomez was pulled up at the top of the stretch and was humanely euthanized on track.

Incident Race 6- #2 Wild Brassy trained by Michael LeCesse and ridden by Luis Perez stumbled at the start and unseated the rider.

Stewards Inquiry and Trainer Objection Race 2- Trainer of the fourth place finisher #4 Stone Crab (Michael Davila, Jr.) claimed foul against third place finisher #1 Fleeting (Chin Yang) for alleged interference in the stretch. After reviewing the video of the race the Stewards made the race official as is.

Stewards Inquiry and Jockey Objection Race 3- Jockey of the second place finisher #7 B Team (Rodolfo Ignacio) claimed foul against second place finisher #1 Crashing Colby (Emanuel De Diego) for alleged interference in the stretch. After reviewing the race video and speaking with the riders involved the Stewards disqualified #1 Crashing Colby from first and placed him second. New order of finish: 7, 1, 3, 5, 4, 6.

Incident Race 2- #1 Fleeting trained by Jeffrey Englehart and ridden by John Davila was pulled up at the 1/8 pole and walked off the track under his own power.

Jockey Movie Review Race 2- Stewards Stuart Rainey, Rick Coyne and Don Combs met with riders Emanuel De Diego and Rodolfo Ignacio regarding the Stewards Inquiry in race 3. After reviewing the race video the Stewards suspended jockey Emanuel De Diego for three racing days.
