Steward's Inquiry – Race 6

FOOTNOTES
 BREED'S HILL Set the pace off the rail, was hooked a furlong out, battled and under pressure held on stubbornly. POLITICAL Unhurried along the two path, chased into the lane, collared the leader a furlong out, battled and under pressure got the job done. SWEETEST PARTY Broke sluggishly, tracked along the three path, angled out in the lane and weakened. BLESSED HONOUR Tracked four wide, five wide on the last turn and tired. CHAMPLAIN Broke sluggishly, four wide after a half mile, took up sharply avoiding the incident at the three-eighths pole and then tired. SUPPORT MISSION Close up early along the rail, drifted out nearing the three-eighths pole into the path of YOUR TOUCH and then appeared to lose the right iron and pulled up. YOUR TOUCH Five wide early, dropped down to the two path after a half mile and then was bothered badly by SUPPORT MISSION at the three-eighths pole, clipped heels with latter and fell. A Stewards inquiry was posted concerning the incident at the three-eighths pole, resulted in no change. Due to a malfunction of the timer the three-quarter time was hand timed.

Stewards Inquiry and Jockey Claim of Foul – Race 9:

ICY DUDE Gained four wide after a half mile, five wide into the last turn, collared the leader, exchanged bumps with that one in the lane, asked and drew off. GENERAL J C Vied for the lead three across after a half mile, drifted in at the seven-sixteenths pole bothering rivals, battled with the winner into the lane, exchanged bumps with that one and then was no match. TRUE BLUE GIANT Checked nearing the last turn, three path around the bend and then made a late bid. JUDITHS COUGAR Five wide into the last turn, four wide entering the lane and made a late bid. HONORABLE UNION Was well placed along the two path, three path on the last turn and made a late bid. ENGINEERS REPORT Vied for the lead along the two path, took up sharply at the seven-sixteenths pole when GENERAL J C drifted in and then weakened. GRAMMI DANCE Vied for the lead along the rail, took up sharply at the seven-sixteenths pole when GENERAL J C drifted in and then tired. OUR GOLDEN LAD Saved ground and tired. A stewards inquiry was posted concerning the incident at the seven-sixteenth pole, resulted in the disqualification of GENERAL J C from second to seventh. Also a claim of foul was lodged by the rider of GENERAL J C against the winner for interference at the eighth pole was not allowed.
