Stewards Inquiry and Jockey Objection Race 2- Jockey of the fourth place finisher #6 Pop Emotion (Oscar Gomez) claimed foul against second place finisher #5 High Heeled Diva (David Lopez) for alleged interference at the top of the stretch. After reviewing the race video and speaking with the riders involved in the judgment of the Stewards this incident altered the outcome of the race and #5 High Heeled Diva is disqualified from second and placed fourth. New order of finish: 4, 2, 6, 5, 1.

Stewards Inquiry and Jockey Objection Race 9- Jockey of the sixth place finisher #5 Lookingformylucky (Chin Yang) claimed foul against first place finisher #2 Gingee (Luis Perez) for alleged interference in the stretch. After reviewing the race video and speaking with the riders involved in the judgment of the Stewards the race was official as is.
