Ruling- Nairo R. Vazquez- Owner- Private Trainer- Having received a report from the NYS Gaming Commission Equine Drug Testing Laboratory of the finding of *diclofenac* in the body fluid sample taken from the horse "Get Busted" (#2) which finished 2nd in the first race on August 17, 2015, having waived his right to appeal, Owner/Trainer Nairo R. Vazquez is suspended for 7 calendar days effective Friday, September 11, 2015 through Thursday, September 17, 2015, inclusive, and fined \$250. In addition, the stewards order "Get Busted" to be disqualified from any part of the purse and the purse redistributed as follows: 1. #1 Coldwater Flat, 2. #6 Muy Man, 3. #4 Buddys Moon, 4. #5 U Whippersnapper, 5. #3 Brother Al
