**Stewards Inquiry and Jockey Objection Race 9-** Jockey of the seventh place finisher #4 Claudia's Vision (Rayan Gazader) claimed foul against third place finisher #8 Quincy Girl (Luis Reyes) for alleged interference in the stretch. In the vicinity of the 1/8 pole #8 Quincy Girl starts in towards the rail and #4 Claudia's Vision briefly steadies. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident did not alter the finish of the race and the race is official as is. Decision was unanimous.

**Stewards Inquiry and Jockey Objection Race 6-** Jockey of sixth place finisher #3 Risetothecasion (Trevor Simpson) claimed foul against third place finisher #9 Peacock Strut (Luis Reyes) for alleged interference near the top of the stretch. #9 Peacock Strut drifts in under a right handed crop taking racing room from #3 Risetothecasion causing him to steady and lose momentum. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident altered the finish of the race and #9 Peacock Strut is disqualified from third and placed sixth. Decision was unanimous. New order of finish: 6, 5, 8, 1, 3, 9, 7, 4, 2.
