**Stewards Inquiry Race 4-** Inquiry into the stretch run, #3 Uncle Duncan (Cornelio Velasquez) takes a bad step and unseats his rider while pulling up and is vanned off. After reviewing the race video and speaking with the riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

**Equine Death Race 4-** #3 Uncle Duncan trained by Linda Rice and ridden by Cornelio Velasquez was pulled up at the 1/16 pole and was taken off on the horse ambulance. Was later humanely euthanized. Claim was voided.

**Incident Race 5-** #1A Pagan trained by Dominick Schettino and ridden by Aaron Gryder was pulled up at the 1/4 pole and taken off on the horse ambulance.
