Stewards Inquiry and Trainer and Jockey's Objection Race 9- Jockey and trainer of the second place finisher #5 Sophia's Choice (Jose Ortiz) claims foul against first place finisher #7 Flat Ware (Javier Castellano) for alleged interference in the stretch. Approaching the wire #7 Flat Ware shifts out and #5 Sophia's Choice has to briefly steady. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

Ruling- Neal Terracciano- Trainer- Having received a report from the New York Drug Testing and Research Program for the finding of the drug "Phenylbutazone" (Bute) in the bodily fluid samples of horse "One More Night" who finished 2nd in the 5th race at Saratoga Race Course on August 23,, 2015. Trainer Neal Terracciano is hereby suspended 15 days and fined \$1000.00. Having appealed at stay has been granted. Having appealed, a stay of the license suspension or revocation is hereby granted; however, Commission counsel may make a motion for the stay to be terminated in the event that the appeal hearing is not completed within 90 days of this ruling. If the stay is terminated because of an unreasonable delay in the completion of the hearing, then the license suspension or revocation would begin and run until the appeal hearing is completed. The licensee is also hereby granted a separate stay that will begin only after the appeal hearing is completed. This second stay will terminate when the Commission issues its final agency action (e.g., finding and order).

Stewards Inquiry Race 3- Inquiry into the start, #7 Infinite Midnight (Manuel Franco) charges the gate without leaving just as the starter takes the start. After reviewing the race video and speaking with all parties involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

Stewards Inquiry and Jockey's Objection Race 7- Jockey of the second place finisher #7 Ocala Jim (John Velazquez) claims foul against first place finisher #5 Make a Decision (Jose Ortiz) for alleged interference in the stretch. In the vicinity of the 1/16 pole #5 Make a Decision shifts in under a right handed crop and brushes with #7 Ocala Jim. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

Stewards Inquiry Race 10- Inquiry into the start, immediately after the break #10 Starago (Samuel Camacho, Jr.) ducks out sharply, unseating the rider. #10 Starago continues out after losing the jockey, forcing #12 Moon Track (Jose Ortiz) out through the temporary rail and onto the widener turf course. After reviewing the race video and speaking with all parties involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

Incident Race 7- #10 Analysis trained by George Weaver and ridden by Manuel Franco was taken off on the horse ambulance after the finish of the race.

Stewards Inquiry Race 8- Inquiry in the vicinity of the 3/4 pole. #1 The Catmancan (Jose Lezcano), #3 Three for Me (Javier Castellano) and #4 Luigi P (Angel Arroyo) come together behind #10 Battle Red (Eric Cancel) and #3 Three for Me steadies. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

Incident Race 9- #5 This Hard Land trained by Rodrigo Ubillo and ridden by Angel Arroyo clipped heels at the start and stumbled unseating the rider.

Incident Race 10- Horse Dearie trained by Leo O' Brien and ridden by Francisco Arrieta unseated the rider prior to being loaded in the starting gate and ran loose and slid under the outer rail of the turf course and was caught by the outrider. Dearie was able to walk off under his own power and was scratched by the Stewards.
