got spooked into the two path at the top of the lane, made no impact. ROBERT VEECEL taken hold after lunging out at the start, tracked the front runners from the pocket, cut the corner into the stretch, backed away. NIENTE chased the pace from path two, angled four wide for the drive home, was in the process of holding her ground suffering an apparent injury to the right front in midstretch, was expertly eased and pulled up, then after being examined by one of the trackside veterinarians, got vanned off. Following a General Stewards' Inquiry, the result was allowed to stand and the race was declared official.

GRINGOTTS stumbled badly at the start losing all footing and belly flopping before recovering athletically with a spring to her feet albeit conceding four to five lengths to the front, chased inside briefly before tipping to the two path, chased two to three wide detached at the tail of the field, went four wide into upper stretch and trailed throughout unable to recover from the rough start. There was a general Stewards' Inquiry into the stretch run before the result was allowed to stand and the race was declared official.

made on the turn, for the signal pole being set approximately signal time, gave out to the left from the right along the rail, argued for control at the moment of three for almost a half, folded. Following a Stewards' Inquiry focusing on DR. DEVERA'S WAY and MACHO BOY in deep stretch, the result was allowed to stand and the race was declared official.
