Stewards Inquiry and Jockey Objection Race 2- Jockey of the third place finisher #2 Run Blondie Run (Junior Alvarado) claimed foul against the first place finisher #4 Jaunt (Jose Lezcano) for alleged interference in the stretch. In the vicinity of the 1/8 pole #4 Jaunt while racing in the middle of the track drifts in towards the rail and #2 Run Blonde Run racing second on the rail has to take up sharply losing his momentum. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident altered the finish of the race and #4 Jaunt is disqualified from first and placed third. Decision was unanimous. New order of finish: 7, 2, 4, 8, 3, 9, 10, 1, 5, 6.

Stewards Inquiry and Jockey Objection Race 4- Jockey of the seventh place finisher #4 Stormin Stephen (Emmanuel Esquivel) claimed foul against fourth place finisher #1 Contradict (Kendrick Carmouche) for alleged interference in the stretch. In the vicinity of the 1/8 pole #4 Stormin Stephen steadied slightly while in between horses. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident did not alter the finish of the race and the race is official as is. Decision was unanimous.

Stewards Inquiry and Jockey Objection Race 9- Jockey of the fourth place finisher #8 City Section (Luis Saez) claimed foul against the first place finisher #6 Big Smile (Jose Ortiz) for alleged interference in the stretch. In the vicinity of the 1/8 pole #6 Big Smile drifts out into the path of the #14 Parabolique (Jose Lezcano) who has to steady and duck out stopping her momentum. In the vicinity of the 1/16 pole #6 Smile Big drifts out into the path of #8 City Selection who has to steady and stop her momentum. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards these incidents did alter the finish of the race and #6 Smile Big is disqualified from first and placed last. Decision was unanimous. New order of finish: 1, 7, 8, 10, 5, 4, 12, 11, 9, 15, 14, 6.
