Stewards Inquiry and Jockey Objection Race 5- Jockeys of the second place finisher #4 Onecats Chance (Jose Ortiz) and third place finisher #2 Be a Hero (Kendrick Carmouche) claim foul against first place finisher #3 Piloting (Junior Alvarado) for alleged interference in the stretch. Inside the 1/16 pole the #2 Be a Hero and #3 Piloting brush twice and then #3 Piloting reacting to the left handed crop comes out sharply and makes contact with #2 Be a Hero who then makes contact with #4 Onecats Chance. After reviewing the race video and speaking to all riders involved the Stewards disqualified #3 Piloting from first and placed him third. Decision was unanimous. New order of finish: 4, 2, 3, 1, 6.

Stewards Inquiry Race 7- Inquiry into the start, #1 Inside Straight (Jose Ortiz) stumbles out of the gate in his first few strides unseating the rider. After reviewing the race video the Stewards determined the horse caused his own problem and made the race official as is. Decision was unanimous.

Stewards Inquiry and Jockey Objection Race 6- Jockey of the second place finisher #8 Grandpa Len (Eric Cancel) claims foul against first place finisher #2 Marriage Fever (Gabriel Saez) for alleged interference in the stretch. Inside the 1/16 pole #8 Grandpa Len and #2 Marriage Fever brush slightly approaching the wire. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.
