In the vicinity of the 3/16 pole, #2 Moonlight Now takes a step out and brushes with #6 Clever Fellow who then shifts in several times brushing the #2 Moonlight Now. After reviewing the race video and speaking to the riders involved, the Stewards did not believe the outcome of the race was affected and made the race official as is.
