**Stewards Inquiry Race 1-** Inquiry into the start, #7 Bartleby (Antonio Gallardo) left the gate prior to the official start of the race. After reviewing the race video in the judgment of the Stewards every horse shall be considered a starter when the stall opens on the signal of the starter and #7 Bartleby gained a clear advantage at the start. #7 Bartleby is hereby removed from the betting pools and unplaced in the order of finish by order of the Stewards. Decision was unanimous. New order of finish: 4, 6, 2, 1, 5.

**Stewards Inquiry and Jockey Objection Race 5-** Jockey of the second place finisher #2 Mighty Zealous (Michael Luzzi) claimed foul against first place finisher #10 Formal Summation (Cornelio Velasquez) for alleged interference inside the 1/8 pole. Both horses were racing wide in the stretch. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards no further action was warranted.

Also #12 Non Stop (Hector Diaz, Jr.) lost a shoe while entering the track prior to the running of race five and the Stewards deemed that #12 Non Stop would run for purse money only.

**Equine Death Race 4-** #1 Frat Star trained by Naipaul Chatterpaul and ridden by Jacqueline Davis fell after the wire unseating the rider and was euthanized on track.

**Equine Death Race 5-** #13 Regulus trained by A.C. Avila and ridden by Dylan Davis broke down in the run down the backstretch and was euthanized on the track.
