**Stewards Inquiry and Jockey Objection Race 5-** Rider of the second place finisher #2 Amazing Anne (Junior Alvarado) claims foul against the first place finisher #6 RY Squadron (Irad Ortiz Jr.) for alleged interference in the stretch. In the vicinity of the 1/16 pole #6 RY Squadron drifts in and #2 Amazing Anne steadies. After reviewing the race video and speaking with all riders involved in the unanimous judgment of the Stewards no action was warranted.

**Stewards Inquiry and Jockey Objection Race 8-** Rider of the third place finisher #1 English Minister (Jose Ortiz) claims foul against the first place finisher #7 Seagate (Angel Arroyo) for alleged interference in the stretch. In the vicinity of the 1/8 pole #7 Seagate drifts out under a left handed crop. #1 English Minister was drifting out prior to the action of #7 Seagate. After reviewing the race video and speaking with all riders involved in the unanimous judgment of the Stewards no action was warranted.

**Stewards Inquiry Race 9-** Inquiry into the stretch run, in the vicinity of the 1/16 pole first place finisher #10 Foxhall Drive (Junior Alvarado) drifts out and then corrects approaching the wire and lightly brushes with second place finisher #2 My Friend Keith (Rajiv Maragh). After reviewing the race video and speaking with all riders involved in the unanimous judgment of the Stewards no action was warranted.

**Stewards Inquiry Race 2-** Inquiry into the stretch run, in the vicinity of the 3/16 pole sixth place finisher #3 Beyond the Green (Kendrick Carmouche) drifts out and makes contact with first place finisher #6 Mark My Style (Cornelio Velasquez). Second place finisher #7 Bullshead Boy (John Velazquez) drifts out after #3 Beyond the Green drifts out and then #3 Beyond the Green drifts back in making contact with #7 Bullshead Boy. After reviewing the race video and speaking with all riders involved in the unanimous judgment of the Stewards no action was warranted.

**Stewards Inquiry Race 3-** Inquiry into the start, #1 Attractive Ride (Luis Saez) dwelt at the start breaking far behind the field and was pulled up shortly out of the gate and returned with the outrider. After reviewing the race video in the unanimous judgment of the Stewards no action was warranted.

**Stewards Inquiry Race 4-** Inquire into incident in the vicinity of the 1/2 mile pole, #8 Summersault (John Velazquez) bobbed slightly and a few strides later bobbles heavily nearly unseating her rider. #1 Khaleesi Kat (Junior Alvarado) runs up on #8 Summersault and clips heels causing #1 Khalessi Kat to unseat her rider. #8 Summersault was later eased in the stretch. After reviewing the race video and speaking with the rider of #8 Summersault in the unanimous judgment of the Stewards no action was warranted.

**Incident Race 4-** #1 Khaleesi Kat trained by William Mott and ridden by Junior Alvarado stumbled at the 3/8 pole and unseated rider Junior Alvarado. Junior Alvarado sustained a black eye and refused to go to the hospital.
