After reviewing the race video and speaking with the rider of the #5 Undertherain in the judgment of the Stewards no action was warranted. Decision was unanimous.

Incident Race 1- #9 Cul Baire trained by James Day and ridden by Paddy Young fell going over the last jump. Appeared both horse and rider were uninjured.

Incident Race 5- #1 The Ghost Bride trained by Abigail Adsit and ridden by Manuel Franco unseated the rider at the 3/16 pole.

Stewards Inquiry and Jockey Objection Race 9- Jockey of the second place finisher #2 Sabbatical (John Velazquez) claims foul against the first place finisher #4 Fresh Feline (Junior Alvarado) for alleged interference in the stretch. After passing the 3/16 pole #4 Fresh Feline drifts out carrying #2 Sabbatical several paths and continues to drift making light contact again with #2 Sabbatical inside the 1/16 pole. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards the incident altered the finish of the race and #4 Fresh Feline is disqualified from first and placed second. New order of finish is 2, 4, 7, 8, 1. Decision was unanimous.

Incident Race 4- #6 Smooth Bert trained by Leah Gyarmati and ridden by Luis Saez was pulled up in the vicinity of the 3/8 pole and taken off the track on the horse ambulance.

Stewards Inquiry and Jockey Objection Race 6- Jockey of the third place finisher #8 Heyaarat (Joel Rosario) claims foul against the first place finisher #5 Global Strike (Javier Castellano) for alleged interference in the stretch. In the vicinity of the 1/8 pole #5 Global Strike shifts in causing #8 Heyaarat to check and alter course. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards the incident altered the finish of the race and #5 Global Strike is disqualified from first and placed third. New order of finish is 3, 8, 5, 4, 2, 1A, 6, 1, 9. Decision was unanimous.

Incident Race 1- #11 Z Big Apple trained by D. Wayne Lukas and ridden by Eric Cancel was pulled up after the finish of the race and taken off on the horse ambulance.

Incident Race 10- #8 Zips Legacy trained by Mark Casse and ridden by Shaun Bridgmohan fell after the finish of the race and walked off under her own power.

Having appealed, a stay of the license suspension or revocation is hereby granted; however, Commission counsel may make a motion for the stay to be terminated in the event that the appeal hearing is not completed within 90 days of this ruling. If the stay is terminated because of an unreasonable delay in the completion of the hearing, then the license suspension or revocation would begin and run until the appeal hearing is completed. The licensee is also hereby granted a separate stay that will begin only after the appeal hearing is completed. This second stay will terminate when the Commission issues its final agency action (e.g., finding and order).

Stewards Inquiry and Trainer Objection Race 8- Jockey of the third place finisher #2 Schivarelli (Corey Lanerie) claims foul against the first place finisher #6 Den's Legacy (Richardo Santana Jr.) for alleged interference in the stretch. In the vicinity of the 1/8 pole #2 Schivarelli has to briefly steady as #6 Den's Legacy drifts in under a right handed crop while passing. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.
