Stewards Inquiry Race 4- Inquiry turning for home, #3 Unholy Alliance (Tyler Gaffalione) shifts in while passing a tiring #2 Lady TNT (Luis Saez) causing #2 to take up. After reviewing the race video and speaking to the riders involved the Stewards did not believe this affected the outcome of the race and the race was declared official as is.

Following a formal film review with the riders involved the Stewards issued a ruling against Tyler Gaffalione.

Stewards Inquiry and Jockey Objection Race 9- In the vicinity of the 1/8 pole, #8 Artie's Princess (Irad Ortiz, Jr.) ducks in under a right handed crop, causing a chain reaction involving #9 She's My Type (Joel Rosario), #6 Bredenburg (Luis Saez) and #7 Lexi On The Move (David Cohen). All were forced to alter course while still in the chase. After reviewing the race video and speaking to the riders involved in the opinion of the Stewards the incident did affect the outcome of the race and #8 Artie's Princess is disqualified from fourth and placed last behind the #6. New Order of Finish: 9-4-5-3.

Following a formal film review with the riders involved the Stewards issued a ruling against Irad Ortiz, Jr.

Stewards Inquiry and Jockey Objection Race 5- Rider #3 Midnight Bisou (Ricardo Santana, Jr.) claimed foul against #4 Vexatious (Jose Lezcano). Approaching the 1/8 pole #4 Vexatious comes out to meet #3 Midnight Bisou. Continuing to battle down the stretch #3 Midnight Bisou comes back in and the two brush near the wire. After reviewing the race video and speaking to the riders involved in the opinion of the Stewards this incident did not affect the outcome of the race and the race is official as is.

Stewards Inquiry, Trainer Objection and Jockey Objection Race 11- Trainer and rider of #2 Cross Border (Jose Ortiz) claimed foul against #6 Sadler's Joy (Javier Castellano). Approaching the 1/16 pole #6 Sadler's Joy comes in under a right-handed crop making contact with #2 Cross Border who in turn knocks into a closing #5 Channel Maker (Manuel Franco) off stride. After reviewing the race video and speaking to the riders involved in the opinion of the Stewards the incident did affect the outcome of the race and #6 was disqualified from first and placed fourth. New order of finish: 2, 3, 5, 6.

Following a formal film review with the riders involved the Stewards issued a ruling against Javier Castellano.
