**Stewards Inquiry and Jockey Objection Race 2-** Jockey of the second place finisher #1 Hinterland (Sean McDermott) claims foul against first place finisher #2 Bob Le Beau (Jack Doyle) for alleged interference at the top of the stretch. #1 Hinterland has to steady as #5 Charminster (Darren Nagle) comes out. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

**Stewards Inquiry and Jockey Objection Race 3-** Jockey of the second place finisher #1 River Date (Manuel Franco) claims foul against first place finisher #4 Shadow Rider (Irada Ortiz, Jr.) for alleged interference in the stretch. In the vicinity of the 1/8 pole #4 Shadow Rider drifts out and #1 River Date steadies briefly, as #4 Shadow Rider crosses in front and marginally clear. #4 Shadow Rider continues to finish first by two lengths over #1 River Date and is pulling away in the final strides. After reviewing the race video and speaking with all riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous

**Incident Race 1-** #2 Artie's Jasper trained by Richard Valentine and ridden by Robert Walsh stumbled after going over the seventh hurdle unseating his rider.
