


Fiscal Year 2016-2017 Year-End Review

Now celebrating its 50th year of service in support of New York's K-12 public schools, the New York State Gaming Commission's Lottery Division is proud to provide this year-end overview of its Traditional and Video Lottery business operations.

New York's Lottery once-again has set an industry gold-standard for its contributions to education, which for the fiscal year ending March 31, 2017, totaled \$3.27 Billion. Combined sales and net win for the same time period totaled \$9.68 Billion.



AID TO EDUCATION

The above amounts are based on the New York State Education Department's Division of Aid to Localities for Education from the State Lottery Fund as required by law. For a complete listing visit nylottery.ny.gov. Lottery revenue is distributed to local school districts by the same statutory formula used to distribute other state aid to education. It takes into account both a school district's size and its income level; larger, lower-income school districts receive proportionately larger shares of Lottery school funding.
